

В ПОИСКАХ ПРИНАДЛЕЖНОСТИ: ПЕРЕОСМЫСЛИВАЯ ИНОГО В ИСТОРИЧЕСКОЙ ПАМЯТИ ВПЛ УКРАИНЫ

Аннотация. *Статья посвящена анализу механизмов памяти и мобилизации исторического прошлого вынужденных переселенцев из Крыма и Донбасса в процессе реартикуляции принадлежности к новым принимающим общинам. В частности, каковы основные измерения и символические маркеры темпоральной локализации принадлежности, демонстрируемые ВПЛ. Автор исследует, строятся ли их нарративы принадлежности как принадлежность по выбору или, скорее, через процессы исключения и отторжения. Исследование основано не только на данных национального опроса «Регион, нация и иное: междисциплинарное и транскультурное переосмысление Украины» за 2017 год, но и на более чем двухстах глубинных интервью, проведенных с 2014 года с переселенцами, покинувшими Крым и Донбасс.*
