

ПОЛІТИКИ І ПРАКТИКИ ДЕ-ІНШУВАННЯ ВИМУШЕНИХ МІГРАНТІВ У СУЧАСНОМУ СУСПІЛЬСТВІ

Анотація. Статтю присвячено переосмисленню конструктивних і деструктивних наслідків політик і практик де-іншування, спрямованих на деконструкцію статусу Іншого/Чужого щодо вимушених мігрантів. На основі теоретичного аналізу та деяких емпіричних застосувань у статті запропоновано комплексну теоретичну модель факторів, що породжують різні соціальні ефекти політик і практик де-іншування. Соцієтальна інтеграція розглядається як ключовий конструктивний ефект політик де-іншування, тоді як радикалізація мільо мігрантів є найбільш небезпечним руйнівним ефектом для суспільства. В рамках моделі ми проводимо аналітичне розрізнення між проявами, соціальними ефектами та їхніми факторами на макро-/мезо- і мікрорівнях соцієтальної інтеграції в конструктивному і деструктивному вимірах політик і практик де-іншування. Ця теоретична модель дозволить дослідникам краще оцінювати і моделювати наслідки цих політик, в тому числі їх переваги для посилення соцієтальної інтеграції, а також ризики їхнього соцієльно деструктивного впливу.
